Day County Planning & Zoning Commission meets monthly at 9:15 a.m. in the Board Room of the Day County Courthouse.
- a.) Application page 1, "Purpose of" in this area write down what you propose to do, operate or build.
- b.) Section of Zoning Ordinances to be exempt page 1, this area will be filled out by the zoning office according to what section of the ordinance pertains to your situation.
- c.) Legal Description page 1, is the legal description of the property where you are asking for the conditional use permit.
- d.) Print & sign your name page 2, along with address and phone number.
- e.) Attach a site plan page 3, on a separate piece of paper of the proposed conditional use area, showing building size, lot lines, existing buildings, building plans, water lines, electric lines of the area, and any other information that may be helpful to the zoning officer.
- f.) Application fee \$75.00 check payable to "Day County Treasurer" to be sent along with application.
- g.) All adjoining landowners will be notified by mail and public notice will be published in the designated newspapers of Day County, South Dakota with the date and time of hearing of the conditional use request.
- h.) Plan to attend the hearing to present your case to the board. You will receive notification from the zoning office as to the date, time & place of hearing.
