The Day County Board of Commissioners convened in regular session at 9:00 AM, Thursday, January 6, 2022 in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Walters. Members present: Commissioners Tobin, Sinner, Walter, and Tompkins. Others: Glenn Gebur, Amanda Fanger-R&F.

PLEDGE: Chairman Walters led the members in reciting the Pledge of Allegiance.

OLD BUSINESS: Chairman Walters called for any old business. Moved by Sinner, seconded by Tobin to make a correction to the contingency transfer for mentally ill from 3,205.00 to 3,265.00. Motion carried.

CLOSE FY2021: There being no further business for 2021, moved by Tompkins, seconded by Sinner to adjourn the 2021 commission. Motion carried.

No meal expense will be reimbursed unless a duly executed voucher is prepared and submitted to the Board of County Commissioners. Meal reimbursement for non-overnight travel will be reimbursed and added to gross payroll up to the maximum amounts as listed above. Mileage: \$.45 per mile for personal vehicle.

There is discussion of creating an ambulance district, the county purchasing and operating the ambulance and an option of the county purchasing the equipment and leasing out the business. The task force plans on getting equipment pricing.
