UNITED STATES DEPARTMENT OF INTERIOR: The Department of Interior gave notice of Non-Gaming Land Acquisition Application. The Sisseton-Wahpeton Oyate has given notice that they filed an application to have real property accepted "in trust". The determination whether to acquire this property "in trust" will be made in the exercise of discretionary authority which is vested in the Secretary of the Interior. The parcels included in this include 07.213.1010; 07.213.1100; 07.213.2000; 07.213.2100; and 07.213.2200 which is a total of 171.49 acres.

REDISTRICTING: Proposed commissioner district boundaries were discussed. The boundaries will be approved at the February 1, 2022 meeting. The proposed boundaries read as followed:

<u>**COMMISSIONER DISTRICT ONE**</u>: consists of Kosciusko Township and Waubay Township including the incorporated limits of the City of Waubay except that portion south of Railway Avenue. <u>**COMMISSIONER DISTRICT TWO**</u>: consists of the incorporated limits of the City of Webster except that portion east of Highway 25 and south of 12th Avenue.

<u>COMMISSIONER DISTRICT THREE</u>: consists of Farmington Township, Andover Township, Homer Township, Union Township, Independence Township, Lynn Township, Raritan Township, Liberty Township, Nutley Township, Grenville Township, Town of Roslyn, Town of Pierpont, Town of Andover and the Town of Grenville.

<u>**COMMISSIONER DISTRICT FOUR**</u>: consists of Bristol Township, Kidder Township, Webster Township except the incorporated limits of the City of Webster, Racine Township, Highland Township, Scotland Township, Valley Township, Butler Township, Oak Gulch Township, Troy Township, York Township, City of Bristol, and the Town of Butler.

<u>COMMISSIONER DISTRICT FIVE</u>: consists of Rusk Township, Morton Township, Central Point Township, Wheatland Township, Egeland Township, that portion of the incorporated limits of the City of Webster east of Highway 25 and south of 12th Avenue, and that portion of the incorporated limits of the City of Waubay south of Railway Avenue.

CORRECTION TO MINUTES: Moved by Sinner, seconded by Tompkins to correct the commissioner minutes from December 28, 2021. The salary schedule stated hourly wage employee Kayla Schimmel at \$19.00. The correction should be \$18.00/hr. Motion carried.
