**April 26, 2022**

The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday April 26, 2022 in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Walters. Members present: Commissioners Tobin, Sinner, Walter, and Tompkins.
