Museum: Duane Anderson with The Museum of Wildlife, Science, and Industry requested \$5,000.00 funding for the 2023 budget year. Anderson reported the updates that have been made at the museum. Moved by Sinner, seconded by Tompkins to approve budgeting \$5,000.00 for 2023. Motion carried.

ECONOMIC DEVELOPMENT: Kelly Hanson and Nick Fosheim presented on behalf of the Economic Development Office. Fosheim shared what they have created as the Community & Economic Development Blueprint.

GROW SD: Katie Rasmus with Grow SD requested \$5,000.00 for 2023 budget year. Rasmus gave a 2021 yearly review and update. No action was taken.

RECESS: Chairman Linda Walters declared a recess at 10:15AM. Chairman Linda Walters reconvened regular session at 10:19 AM.

PUBLIC HEARING- ALCOHOLIC BEVERAGE LICENSE TRANSFER: Public Hearing was held for transfer of Package Off-Sale. Moved by Walter, seconded by Sinner to approve the following Package Off-Sale Liquor License Transfer:

RECESS: Moved by Walter, seconded by Sinner to recess the regular meeting at 10:25 AM and conduct the County Tax Sale. Motion carried.

Chairman Walters reconvened the regular meeting at 10:36 AM. Moved by Sinner, seconded by Tompkins to approve the bid on the following parcel and issue Quit Claim Deed. Walter opposed. Motion carried.

TAHOE: Sheriff Schreur reported that his Tahoe is all fixed from the car accident. Schreur stated one Tahoe is still waiting for lights and siren install.

VEST: Sheriff Schreur asked the board if they would like to buy the vest for Deputy Premus from the City of Webster or purchase a new one. Moved by Walter, seconded by Tompkins to approve Sheriff Schreur to purchase the vest from the City of Webster at half the price of a new vest. Motion carried.

PUBLIC HEARING- DELETION OF COUNTY ROAD: Public Hearing was held to approve a resolution to delete approximately ½ mile of 138th ST starting at the southwest corner of Section 34, T123N, R53W at the intersection of 446th Ave, then east approximately .499 miles to the intersection of 446A Ave, Waubay Township, Day County, SD. Members from the public were present and voiced concerns. Merlyn Drake with Waubay Township would like to see the County trade roads if this deletion from the County would fall upon the Township. Moved by Walter, seconded by Tobin to table passing a resolution for deletion until more information is received. Motion carried.

AMBULANCE PURCHASE AGREEMENT: Moved by Walter, seconded by Sinner to approve Chairman Walters to accept and sign the purchase agreement between Day County and

Christensen Ambulance for equipment purchases in the amount of \$350,000.00. Motion carried. Roll Call Vote: Sinner-yes; Tompkins-yes; Walters-yes; Walter-yes; Tobin-yes.

RECESS: Chairman Linda Walters declared a recess at 11:32 AM to go to the Fair Grounds and do a walk through. Chairman Linda Walters reconvened regular session at 12:34 PM.

WATER LINES: Chris Barse, Harvey Opitz, Shonda Holscher, and Christina Hanson with the Fair Board presented a quote from Glacial Lakes Excavating for new water lines at the Day County Fairgrounds in the amount of \$25,197.44 for install and materials. Barse stated that the Fair Board does not currently know where existing water lines run. Fair Board would put in all new piping on the outside of the grounds so new buildings would have the availability to tie into the water lines. The project has 7 hydrants and two-inch pipe. It would cover approximately 700-1,000 additional feet which includes the Horse Arena not proposed by the leaders. The Leaders quote from the previous meeting was in the amount of \$24,069.51 for materials. The Fair Board's quote was drafted 4/24/2022, Harvey Opitz has checked with Glacial Lakes Excavating and they would honor the price still at this time. The Fair Board has been working with the Leader's on expansion and replacing of water lines since January. The Fair Board does not currently have the funds to pay for this replacement at this time. 4-H Leaders Amy Fischer and Merrie Atherton were present to discuss options. Chairman Linda Walters asked that the Leaders take this quote back to their board and discuss considering the Fair Board's proposal. She asked them to figure out how they can work together and meet in the middle, as it is very similar project just different layouts and need to get the most "bang for their buck", and if they would still be willing to donate funds towards the project. The two boards are to meet back at the July 19 meeting. The 4-H Leaders are to deliver their quote to the Auditor's Office.

SAFETY MANUAL: Moved by Tompkins, seconded by Sinner to adopt the Safety Manual. Motion carried.

COURTHOUSE CLOSURE: Day County Courthouse and Highway Department will be closed Monday, July 4, 2022 in observance of the 4th of July Holiday.

ADJOURNMENT: Moved by Sinner, seconded by Tompkins to adjourn until 9:00 AM, Tuesday, July 5, 2022 to convene in the Commissioners Chambers in the Day County Courthouse. Motion carried.
