DAY COUNTY COMMISSION WEBSTER, SOUTH DAKOTA August 16, 2022

The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday August 16, 2022 in the Commissioner Chambers in the Day County Courthouse. Meeting called to order by Chairman Walters. Members present: Commissioners Tobin, Sinner, Walter, and Tompkins. Others: Auditor Zimmerman, States Attorney Knight, Amanda Fanger R&F, Glenn Gebur, Shayne Schmieg, Chloe Rithmiller, Rick Froslie, and Justin Carlson.

PLEDGE: Chairman Walters led the members in reciting the Pledge of Allegiance.

CORRESPONDENCE: Letter from SDACC President Karsky.

PUBLIC COMMENTS: Glenn Gebur asked the Board if Day County hired a weed sprayer? Gebur asked why the weed spraying in the riprap was not done. Rick Froslie reported his observation from the Day County Fair was that not all buildings were handicap accessible. Froslie asked the Board if they would accept 2 wheelchair ramps from him to use at the Exhibit Building and the Pavilion. Glenn Gebur also commented that the Rabbit Building was not Handicap accessible. Commissioners thanked Froslie for bringing it to their attention and for his donation to Day County.

PLANNING/ZONING: Moved by Walter, seconded by Tobin to recess the regular session at 9:14 AM, to convene as Planning, Zoning and Drainage Board. Motion carried. Chairman Linda Walters reconvened the regular session at 9:43 AM.

PLAT: Upon recommendation of the Planning & Zoning Board, moved by Sinner, seconded by Tompkins to approve the following plat: 1) Tvinnereim-Meyer Addition in SE 25.123.57. Motion carried.

EXECUTIVE SESSION: Moved by Sinner, seconded by Tompkins to enter into Executive Session at 9:49 AM for personnel matters as per SDCL 1-25-2. Motion carried. Chairman Linda Walters reconvened the regular session at 10:11 AM.

B.D.M PUBLIC HEARING: Public Hearing was held on B.D.M Rural Water System, Inc. requesting authority to install water lines and appurtenances within Day County road rights-of-way. Moved by Tobin, seconded by Tompkins to adopt Resolution 2022-11 granting B.D.M Rural Water System, Inc., a county wide authorization for the purpose of the continued placement, repair, and maintenance of pipeline. Motion carried.

RESOLUTION NO. 2022-11

BE IT RESOLVED that BDM Rural Water System, Inc., a South Dakota Non-profit Corporation, will be allowed and permitted to run an underground pipeline for transmitting water or all purposes for which said corporation was formed along any and all public rights-of-way, including pipelines, appurtenances, all rights-of-way between all sections in Day County, South Dakota, so long as said transmission and distribution pipe is buried, so as not to interfere with the building of any roads or causing any liability to the County.

BE IT FURTHER RESOLVED that BDM Rural Water System, Inc. will bear the expenses or costs associated in the construction and operating of the water system.

BE IT FURTHER RESOLVED that when a pipeline is installed in the public right-of-way, such right-of-way must be restored to as near its original condition as is practical with normal construction methods.

BE IT FURTHER RESOLVED that the installation of such pipeline and appurtenances in the public right-of-way will conform to plans and specifications to be submitted to the County, prior to construction, for review and comment, and must include the following conditions:

- 1. <u>Notice Prior to Starting Work</u>: Before starting construction work, the County Highway Superintendent or other designated employee of the County will be notified at least 48 hours in advance of the time work is to begin.
- 2. <u>Minimum Interference with Traffic</u>: All work will be planned and carried out so as to minimize inconvenience to the traveling public.
- 3. <u>Storage of Material</u>: No material may be stored within eight feet from the edge of pavement or traveled way or within the shoulder line unless otherwise approved by the County Highway Superintendent.

- 4. <u>Clean Up Right-of-Way</u>: Upon completion of work, litter will be removed from the right-of-way, and it will be left in as presentable a condition as before work started.
- 5. <u>Care of Drainage</u>: If the contemplated work interferes with established drainage, provisions will be incorporated in the project during construction to maintain normal drainage.
- 6. <u>Location Plans</u>: Upon completion of the work, a copy of the "as built" drawings will be furnished to the County for their records and use.
- 7. <u>Maintenance</u>: The pipelines and appurtenances placed in the County right-of-way will be maintained and reasonable care exercised in inspecting and repairing any portion of the right-of-way and pay all expenses or costs to the County which occurs as a result of the operation and maintenance of the pipelines and appurtenances.
- 8. <u>Paved and FAS (Future Paved) Roadways</u>: Pipelines installed perpendicular to asphalt or concrete paved roadways will be installed by boring or jacking methods or by an open cut. Pipelines installed longitudinally in a right-of-way will be by an open cut. Minimum of one-half of paved surfacing will be left clear and open to traffic at all times. All lanes will remain clear and open during the hours of darkness.
- 9. <u>Graveled and Other Roadways</u>: Pipelines installed transversely or longitudinally in a graveled or other road right-of-way will be by an open cut method. Roadways may be closed during construction for crossing, provided a detour signing is maintained. All lanes will remain clear and open during the hours of darkness.
- 10. <u>Depth of Pipelines</u>: Pipelines will be placed to a depth of cover consistent with design standards for water pipelines for the area. Where additional pipeline cover is necessary to accommodate future roadways, vertical and horizontal roadway designed clearances, the County will so advise BDM Rural Water System, Inc. at the time of the County review of the need for change in pipeline cover.

BRISTOL BRIDGE: Bristol City Council Member Shayne Schmieg and Finance Officer Chloe Rithmiller appeared before the board to ask for help in paying for the repair of the Bristol Bridge. A quote to fix the Bridge from Hollaway Bridge and Culvert, Inc. was presented in the amount of \$91,386.90. Schmieg stated that the City of Bristol feels that it is an emergency situation, and they should fix it as soon as possible. If they notify Hollaway Bridge by August 17th the project could be completed by the end of September. It is still unknown exactly who owns the bridge. Chairman Walters asked if the city had COVID money to spend on infrastructure. Finance Officer Rithmiller said that money has been designated to a ground sewer project. Schmieg said City does have the money to cover the cost but is asking that the County consider contributing possibly a third of the project expense. Commissioner Sinner said he agrees that they should help, he is just concerned about setting a precedent for other cities and with taking on the ambulance service he is just not sure they can swing that at this time. No decision was made.

LOCAL EMERGENCY MANAGEMENT PERFORMANCE GRANT: Moved by Tobin, seconded by Tompkins to approve the Chairman to sign the Local Emergency Management Performance Grant. Motion carried.

VSO COMPUTER QUOTE: Auditor Zimmerman presented a quote on behalf of VSO Nelson for a new computer with docking station and software. The quote received was from Glacial Lakes Technology Services for \$2,800.00. Moved by Sinner, seconded by Walter to approve the quote with Glacial Lakes Technology Services. Motion carried.
