BID RECOMMENDATION: Moved by Tobin, seconded by Walter that Day County Commissioners recommend to SD DOT to award the low bidder for Structure Replacement 19-010-132 (3 miles west and one mile south of Andover) to BX Civil & Construction with a bid of \$449,064.00. Motion carried. Bid letting was held November 4, 2022. All bids are on file at the Auditor's Office.

TWO 2024 GRANITE MACK TRUCKS OFF SPINK COUNTY BID: Highway Supt. Braaten informed the board that his previous bid from September 21, 2021 to purchase two (2) 2023 Mack Trucks for \$119,500.00 each has been canceled, as Mack is no longer accepting the bids. Moved by Tobin, seconded by Tompkins to approve Highway Supt. Braaten to purchase two (2), 2024 Mack Trucks from Transource off of the Spink County bid in 2022 in the amount of \$148,500 each. Trucks will be delivered and paid for in 2023 and contract will be signed in 2022. Motion carried.

CHAIRMAN TO SIGN HAZARD MITIGATION GRANT PROGRAM: Moved by Tobin, seconded by Walter, to approve the Chairman to sign the Hazard Mitigation Grant Resolution 2022-13. Motion carried.

LAKE REGION DISTRICT MEETING: Grant County will host the Lake Region District Meeting in Grant County on November 16, 2022.

LIQUOR LICENSE: Moved by Walter, seconded by Tompkins to approve renewing the 2023 Liquor licenses for Bitter Lake Lodge, Hilltop Steakhouse, Dale's Service Inc. (Hot Spot), Pickerel Lake Corner and Pickerel Lake Lodge. Motion carried.

AMBULANCE DONATIONS FUND: Moved by Walter, seconded by Tompkins, to transfer Ambulance Donation Money from restricted fund balance to unassigned fund balance to purchase radios for the ambulance department in the amount of \$2,641.15. Motion carried.

AUTO-SUPPLEMENT GENERAL GOVERMENT BUDGET: Moved by Walter, seconded by Tobin to approve the automatic budget supplement to the General Government (maintenance) budget (101-4-161-425.7) \$50,000.00 from money received from LATCF Federal Grant Funds for capital expenses to government admin buildings. Motion carried.

DEPENDABLE SANITATION: Department of Agriculture and Natural Resources completed a routine inspection of the Dependable Sanitation facility. Based on the inspection, it is operating at a satisfactory compliance manner.

2023 WAGES: Auditor Zimmerman reported that the first payroll of 2023 will begin December 18th, 2022 and commissioners should start thinking of what they would like to do with wages for 2023. No action was taken.
