The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, January 3, 2023 in the Commissioners Chambers in the Day County Courthouse. **WAGE INCREASE:** Sheriff Schreur recommended a pay increases for employees Josh Hoven and Amanda Bartelt. Schreur stated he would like to see Chief Deputy Hoven at \$27.00/hr and Amanda Bartelt at \$25.00/hr. Moved by Tompkins, seconded by Walter to approve Chief Deputy Hoven a \$0.50 pay increase. After discussion, Tompkins retracted his motion until after executive session was held. Moved by Kjos, seconded by Tompkins to approve a \$0.50 pay increase to Chief Deputy Hoven (\$25.50/hour to \$26.00) effective January 2<sup>nd</sup>, 2023 and to table Amanda Bartelt pay increase. Motion carried.

**HWY DEPT. SEALED BIDS:** Moved by Tompkins, seconded by Walter to authorize Hwy Supt. **CHAIRMAN TO SIGN EASMENT FOR BRIDGE 19-025-030:** Moved by Kjos, seconded by Tompkins to approve Chairman Sinner to sign five easements with landowners for Bridge 19-025-030 (in Farmington Township on 127<sup>th</sup> St.). Motion carried.

**EXECUTIVE SESSION:** Moved by McGregor-Okroi, seconded by Walter to enter into Executive Session at 9:36 AM for personnel matters as per SDCL 1-25-2. Motion carried. Chairman Sinner reconvened the regular session at 10:15 AM.

**HANDICAP ENTRANCE:** Perry Althoff spoke on behalf of the Handicap Entrance. He asked that rails be put on both sides of the steps.

**RECESS:** Chairman Sinner declared a recess at 10:22 AM. Chairman Sinner reconvened the regular session at 10:27 AM.

**FLIGHT TEAM RATE:** Moved by Walter, seconded by Tompkins to add a flight team rate of \$300.00 to resolution #2022-15. Motion carried.

**CAMERAS:** Ambulance Director Madsen would like to obtain quotes for cameras at the Ambulance garage. Madsen will obtain quotes and report back to the commission.

**ADDITIONAL STAFF:** Ambulance Director Madsen stated that the Ambulance Service has been very busy. He would like to get additional help for 40 hours to get caught up. Moved by Walter, seconded by Tompkins to hire Cassidy Sivertson for temporary help for 40 hours at \$20.00/hr. Motion carried.

**PRINTER:** Director Madsen stated his printer problem has been resolved. No action taken.

**PICK-UP:** Director Madsen stated he would like to add the old Sheriff's pick-up to his inventory and use it to move supplies and go back and forth between ambulance shed, highway shop and courthouse. Chairman Sinner suggested Madsen use the county van to get around as the board hasn't agreed on having a first responder vehicle yet at this time. Commissioner Kjos stated we should try to prevent throwing additional expenses towards it until we know where we are sitting financially. Commissioner Walter stated he didn't believe we needed a pick-up as a first responder truck, as it should be the ambulance. No action was taken.
