**ALCOHOLIC BEVERAGE LICENSE HEARING:** Public Hearing was held at the set time. No one from the public appeared. Moved by Walter, seconded by Tompkins to approve the new "Retail (on-off sale) Malt Beverage and SD Farm Wine" alcoholic beverage license for the 12 Spot Diner, LLC for the 2023-24 licensing period. Motion carried.

**JAIL TOILETS:** Sheriff Schreur gave an update on the toilets at the jail. There are 11 toilets that will need to be replaced in the future. Schreur stated it costs roughly \$6,000.00 per toilet. For now, Schreur will start with replacing the flush valves, but informed the board to look at the future expense of toilet replacement.

**ROSLYN CONTRACT:** Sheriff Schreur gave an update on the contract with the City of Roslyn. Roslyn City Council met July 10 to review the contract agreement. If Roslyn agrees, Schreur will present it back to the board at the next meeting.

**EXECUTIVE SESSION:** Moved by Kjos, seconded by Tompkins to enter into Executive Session at 9:30 AM for legal matters as per SDCL 1-25-2. Motion carried. Chairman Derek Sinner reconvened the regular session at 9:52 AM

**AMBULANCE CONTRACT HOURS:** Discussion was held about the Ambulance Service providing special event coverage. Rates were set at \$80.00/hr for 1 Ambulance and 2 EMT's: \$50.00/hr for 1 EMT with emergency bag. Staff will be paid during event time as "run" time. Moved by Kjos, seconded by Walter to approve contract hourly rates. Motion carried. Director Madsen is advised to check around with other counties on their contract hour prices and services.

SURPLUS AMBULANCE AND SELL TO LAKE NORDEN: Moved by Walter, seconded by Kjos to surplus the 2001 Ford E450 Ambulance and one cot and sell to Lake Norden Ambulance service in the amount of \$10,000.00. Roll call vote: Sinner-yes; Walter-yes; Kjos-yes; McGregor-Okroi-yes; Tompkins-yes. Motion carried. Director Madsen was advised to check with the State to see if the Lifepack needs to be returned back to them.

**SURPLUS COTS:** Moved by Tompkins seconded by McGregor-Okroi to surplus two ambulance cots and destroy. Motion carried.

**TRAVEL UPDATE:** Ambulance Director Madsen reported to the board that he will be attending the SDEMSA Conference in Pierre. This will be at no cost to the County.

**LIFEPACK TRAINING:** Ambulance Director Madsen asked for approval for himself and one staff member to attend Lifepack Training in Aberdeen July 25, 2023. Moved by Walter, seconded by McGregor-Okroi for employees to travel to training. Motion carried.

**NEW HIRES:** Moved by Kjos, seconded by Tompkins to hire Chris Anderson and Madison Coester as part-time/volunteer with no benefits Drivers at \$14.00/hr effective July 2, 2023. More information on overtime will need to be considered before hiring Garret Premus. Motion carried.

**BID LETTING APPROVAL:** Bid letting to crush gravel was held at 10:00 AM, Monday July 10<sup>th</sup>, 2023. Bids were received from CT Sibson Gravel, Rogge Excavating Inc., and Eastman Inc. On recommendation from Hwy. Supt. Braaten moved by Tompkins, seconded by McGregor-Okroi to accept the low bid from Eastman Inc. to crush gravel in Opitz Pit. Motion carried.

**CULVERTS IN GRENVILLE:** No one on behalf of Tamara Lesnar or Michael Gonzales appeared.

**COMMISSIONER TRAVEL:** Commissioner Jim Walter gave an update on the meeting he attended about changing the reservation boundaries. Moved by Kjos, seconded by Tompkins to approve travel and pay mileage for meetings attended by Commissioner Walter. Motion carried.

**RECESS:** Chairman Sinner declared a recess at 10:37 AM. Chairman Sinner reconvened the regular session at 10:42 AM.

**2024 BUDGET DISCUSSION:** 2024 Budgets were passed out and discussion was held. Commissioners will review and discuss at the next meeting.
