The board reduced the Coroner Budget from \$14,370.00 to \$5,500.00; County Fair from \$20,000.00 to \$15,000.00; Increase cash transfer out of General Fund by 10,000.00 and Increase OEM transfers in by \$10,000.00. Moved by Kjos, seconded by Tompkins to adopt and have Auditor Zimmerman publish the Provisional Budget. The first Budget Hearing is scheduled for September 5, 2023.

EXECUTIVE SESSION: Moved by Kjos, seconded by Tompkins to enter into Executive Session at 11:23 AM for personnel matters as per SDCL 1-25-2. Motion carried. Chairman Derek Sinner reconvened the regular session at 11:58 AM.

ADJOURNMENT: Moved by Tompkins, seconded by McGregor-Okroi to adjourn until 9:00 AM, on Tuesday August 22, 2023, to convene in the Commissioners Chambers in the Day County Courthouse. Motion carried.
