The location of the purposed grade raise is on Day County Road One / 446<sup>th</sup> Ave over Blue Dog Lake, beginning at approximately <sup>1</sup>/<sub>4</sub> mile north of US Highway 12. Phase one of this study would evaluate the cost and benefits of a grade raise along this section of roadway, which is approximately 5,000 feet. Moved by Walter, seconded by McGregor-Okroi to approve resolution #2023-06 and sign Designation of Applicant Agent. Motion carried.
