2023 TRAIL KING BELLY DUMP: Moved by Tompkins, seconded by Kjos to accept the bid through Sourcewell and purchase a 2023 Trail King Belly Dump Trailer in the amount of \$62,307.00. Motion carried.

NEW HIRE: Moved by Walter, seconded by Kjos to hire Mitzi Yanish and Jesse Spitzer as part-time with no benefits Ambulance Driver at \$14.00/hr effective November 19, 2023. Motion carried.

AMBULANCE PURCHASE: Ambulance Director Madsen presented a 2006 Ambulance that he is interested in purchasing. No action was taken.

AMBULANCE UPDATE: Director Madsen advised that Day County gets mutual aid agreements with surrounding counties. Ambulance has had 446 calls as of January 2023. Madsen would also like to thank the Waubay Senior Citizens for the donation of winter coats.

EXECUTIVE SESSION: Moved by Kjos, seconded by Tompkins to enter into Executive Session at 10:19 AM for personnel matters as per SDCL 1-25-2. Motion carried. Chairman Sinner reconvened the regular session at 11:06 AM.

PERSONNEL POLICY: Moved by Kjos, seconded by Tompkins to adopt the 2024 Personnel Policy effective January 2, 2024. Motion carried.

AUTO-SUPPLEMENT GENERAL GOVERMENT BUDGET: Moved by Walter, seconded by Kjos to approve the automatic budget supplement to the General Government (maintenance) budget (101-4-161-425.7) \$50,000.00 from money received from LATCF Federal Grant Funds for capital expenses to government admin buildings. Motion carried.

SURPLUS: Moved by Kjos, seconded by Tompkins to surplus and destroy 13 chairs. Motion carried.

VSO RE-APPOINTMENT: Moved by Walter, seconded by Kjos to re-appoint Jeffery Nelson as the Day County Veterans Service Officer for a period of four years, through the first Monday in January, 2028. Motion carried.

SD DEPT OF HEALTH: The South Dakota Department of Health has requested Naloxone be mounted in a protective box in the county building where the Community Health Office is located. The DOH employee is the designated point of contact who will be responsible for routine monitoring. Moved by Kjos, seconded by Tompkins to approve partner with the SD Dept. of Health office to have Naloxone available. Motion carried.
