The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday December 5, 2023, in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Sinner. Members present: Commissioners Kjos, Walter, and Tompkins and McGregor-Okroi. PLEDGE: Chairman Sinner led the members in reciting the Pledge of Allegiance.

CORRESPONDENCE: None. **PUBLIC COMMENTS:** None.

MINUTES: Moved by Tompkins, seconded by Walter to approve the minutes from November 21, 2023, regular commissioner meeting. Motion carried.

PAYROLL: Moved by Kjos, seconded by Tompkins to approve and authorize the chairman to sign the payroll period ending November 18, 2023. Motion carried.

NEW HIRE: Moved by Tompkins, seconded by Kjos to approve hiring Jessica Wik as 60% Register of Deeds Deputy and 40% Nurse clerical at \$21.25 effective December 18th, 2023. Motion carried.

EMPLOYEE RAISE: Highway Supt. Braaten recommended a six-month pay increase for Highway worker Nick Gronke. Moved by Kjos, seconded by Tompkins to approve a \$0.50 pay increase for Nick Gronke effective December 3, 2023. Motion carried.

AUTO SUPPLEMENT: Moved by Tompkins, seconded by Walter to approve making an auto supplement to the Highway budget (201-4-311-437 Highway Road Construction) for unanticipated

expenses of \$100,000.00 for Road Maintenance. Revenue Reimbursement from State Grants. Motion carried.

RESIGNATION: Moved by Tompkins, seconded by Walter to accept with regret a letter of resignation from Highway worker James Pearson effective November 21, 2023. Commissioners thanked him for his years of service. Motion carried.

SNOW TRANSFER: Moved by Walter, seconded by McGregor-Okroi to approve a fund balance transfer of \$514.98 from Fund Balance Snow (201-274.05) to Highway Assigned FB Road Purpose (201-276.03). Motion carried.

4-H/EXTENSION UPDATE: Jennifer Ringkob, Program Advisor for Extension, gave a year end recap for the extension office.

MOU BETWEEN SDSU EXTENSION AND DAY COUNTY: Moved by Kjos, seconded by Tompkins to approve the chairman to sign the MOU between SDSU Extension and Day County for the 2024 year. Motion carried.

NEW HIRES: Moved by Walter, seconded by Tompkins to approve hiring Jennifer Steffes as part time with no benefits Ambulance Nurse at \$20.00/hr and Barbara Baker as part time with no benefits Ambulance EMT at \$16.00/hr effective December 17, 2023. Motion carried.

AMBULANCE UPDATE: Ambulance Director Madsen said they have taken 457 calls since January 1, 2023. Working on Mutual Aide Agreement with Clark County. Also working on sharing some education/training costs. An outstanding bill with Reporter and Farmer was discussed. Director Madsen was advised when purchasing inventory for the ambulance he should submit vouchers.

2024 WAGES: Wages for 2024 budget year were discussed. Commissioner Walter would like to see Ambulance, Highway, and Jail all classified as Public Safety Employees and be on a different salary scale than the Courthouse employees. Discussion was held on a two-scale system. Moved by Tompkins, seconded by Kjos to approve a .50 cent pay increase for all employees who have been employed for more than 6 months effective first pay period in 2024. Walter and McGregor-Okroi opposed. Motion carried.

FAIR BOARD LEASE AGREEMENT: Moved by Tompkins, seconded by Kjos to approve and authorize the chairman to sign the 2024 Annual Fair Board Lease Agreement. Motion carried.

PUBLIC DEFENDER CONTRACT: Moved by Kjos, seconded by Tompkins to authorize the chairman to sign the 2024 Public Defender Contract for \$90,000 with Delaney, Nielsen & Sannes. Motion carried.

NECOG JOINT COOPERATIVE AGREEMENT: Moved by Tompkins, seconded by Kjos to approve and authorize the chairman to sign the Joint Cooperative Agreement with NECOG for 2024. Motion carried.

HOLIDAY CLOSURE: Day County Courthouse and Highway Department will be closed December 25 and 26, 2023 in observance of Christmas and January 1, 2024 in observance of New Years.

EXECUTIVE SESSION: Moved by Kjos, seconded by Tompkins to enter into Executive Session at 9:40 AM for personnel matters as per SDCL 1-25-2. Motion carried. Chairman Sinner reconvened the regular session at 10:17 AM.

HIRE: Moved by Kjos, seconded by Walter to approve hiring for the Auditor position. Motion carried.

LETTER OF RESIGNATION: Moved by Kjos, seconded by McGregor-Okroi to accept with regret a letter of resignation from Commissioner James Tompkins, District 2 effective December 5, 2023 and to appoint Janet Marx effective December 5, 2023 to fill the vacancy of Commissioner District 2. Walter voted No. Motion carried.

ADJOURNMENT: Moved by Kjos, seconded by Walter to adjourn until 9:00 AM, Tuesday, December 19, 2023, to convene in the Commissioners Chambers in the Day County Courthouse. Motion carried.
