DAY COUNTY COMMISSION WEBSTER, SOUTH DAKOTA December 28, 2023

The Day County Board of Commissioners convened in regular session at 9:00 AM, Thursday December 28, 2023, in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Sinner. Members present: Commissioners Kjos, Walter and Marx.

PLEDGE: Chairman Sinner led the members in reciting the Pledge of Allegiance.

CORRESPONDENCE: None.

PUBLIC COMMENTS: Glenn Gebur stated he was approached at the grocery store and was questioned why elected officials are sitting in on public meetings. He proceeded to go home and read SDCL 7-7, which explains all duties of elected officials and believes everyone should read that. Gebur said the question from last meeting has still not been answered on why the elected officials are sitting in on public meetings. The only thing that he could personally come up with is that the elected officials don't trust the County Commissioners. Gebur believes that it is a misuse of tax dollars. Commissioner Sinner stated that it is a public meeting, and anyone is welcome to attend. Treasurer Zubke commented that after the last meeting she reached out to Executive Director Jacobson and asked if public officials should not be sitting in on public meetings. Jacobson said she would never advise anyone to tell the public or elected officials that they should not sit in on a public meeting. ROD Berger and Treasurer Zubke reported that they had constituents tell them that they are glad that they are sitting in on the public meetings.

EMPLOYEE WAGE INCREASE: Moved by Marx, seconded by Kjos to approve \$1.00 per hour pay increase to Highway Dept. worker Nick Gronke (21.73 to 22.73) effective December 31, 2023, upon receiving CDL. Motion carried.

SMALL STRUCTURE APPLICATIONS: Moved by Kjos, seconded by Walter to award four (4) small structure applications from the following Townships: Farmington (2), Andover and Kosciusko. Andover Township will pay 100% of the construction costs and the County will pay for 100% of the culvert cost. The County will pay for 100% of the upfront project cost for Farmington and Kosciusko Townships. Once invoices are paid, the County will bill Farmington and Kosciusko Townships for 20% of the project costs to be reimbursed. Highway Supt. Braaten hopes to be able to award Union Township with a small structure project in 2024. Motion carried.

AUDITOR: Moved by Kjos, seconded by Walter to approve hiring Karli Zimmerman as a part time employee in the auditors at \$38.50/hr with no benefits, effective January 2, 2024. Motion carried.

AMBULANCE: Auditor Zimmerman presented an end of year recap for the Ambulance Department. As of 12/27/2023 revenue received from Ambulance billing amounted in \$244,903.63, expenditures amounted in \$280,872.87. As of November 30, 2023, outstanding accounts receivable (claims submitted) amounted to \$264,886.14 (expected to collect 65%). Other revenues are as listed; Restricted Fund Balance for Ambulance Donations \$9,252.15; Restricted Fund Balance for Ambulance Vehicle \$7,000.00; Special Event Coverage \$2,020.00; State Grants \$86,481.11; and other Intergovernmental Revenue of \$27,200.00. The Board would like to thank the Cities and Townships that donated to the County, along with the private donations given.

EXECUTIVE SESSION: Moved by Marx, seconded by Kjos to enter Executive Session at 9:35 AM for personnel matters as per SDCL 1-25-2. Motion carried. Chairman Sinner reconvened the regular session at 10:30 AM.

ADJOURNMENT: Moved by Walter, seconded by Marx to adjourn until 9:00 AM, Thursday, January 4, 2024, to convene in the Commissioners Chambers in the Day County Courthouse. Motion carried.
