The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, July 2, 2024, at the Day County Museum of Wildlife, Science & Industry. Meeting called to order by Chairman Sinner. Members present: Commissioners McGregor-Okroi, Marx, Walter and Kjos. PLEDGE: Chairman Sinner led the members in reciting the Pledge of Allegiance.

MILEAGE: Moved by McGregor-Okroi, seconded by Marx to approve to follow state increase of mileage reimbursement rate as of July 1, 2024, from \$.51 a mile to \$.655 a mile. Motion carried.

BUDGET DISCUSSION: 2025 Budgets were passed out and discussion was held on proposed budgets.

AMBULANCE REPLACEMENT: Moved by Marx, seconded by McGregor-Okroi to accept the insurance replacement coverage in the amount of \$50,000.00. Motion carried.

Discussion was also held on donations to the ambulance and ideas for fundraisers to help with replacement expenses.

ADJOURNMENT: Moved by McGregor-Okroi, seconded by Marx to adjourn until 9:00 AM, Tuesday, July 16, 2024, to convene in the Commissioners Chambers in the Day County Courthouse. Motion carried.
