DAY COUNTY COMMISSION WEBSTER, SOUTH DAKOTA August 20, 2024

The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, August 20, 2024, in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Sinner. Members present: Commissioners McGregor-Okroi, Marx, Walter and Kjos. PLEDGE: Chairman Sinner led the members in reciting the Pledge of Allegiance.

CORRESPONDENCE: A letter was read to Commissioners from Reuben Parks requesting the postponement of the of the final reading of Ordinance #2024-1 and grant a stay of action on the final reading and the final vote on the ½ mile setback. Parks proposed a ¾ mile minimum setback for Day County.

PUBLIC COMMENTS: Tom Sannes, Webster Area School board president, thanked the Commissioners for the time and efforts that go into making decisions on the commission board. Sannes voiced that the decisions Commissioners make on the wind tower setback are long term decisions and need to benefit all taxpayers and that the decision made is a big deal for the school districts for the increase of their funding. Sannes stated that he hoped the Commission would support the ½ mile setback and keep development happening.

Moved by Kjos, seconded by Marx to approve the purchase of additional fiberoptic lines for \$9300.00 including installation. Motion carried.

COMPUTER REPLACEMENT: Director Anderson also had a discussion on the replacement of a dispatch computer. Move by Kjos, seconded by McGregor-Okroi to approve the purchase of a dispatch computer. Motion carried.

SHERIFF TRAVEL REQUEST: Moved by McGregor-Okroi, seconded by Marx to approve travel for Mandy Bartelt in September for FBI Nics Training on permits for state and federal pistol and concealed weapons. Motion carried.

HIGHWAY: Superintendent Braaten gave his update on the topcoat chipseal on County Road 18 by Bristol and Lily and been hauling gravel to County Road 10.

EXECUTIVE SESSION: Moved by Marx, seconded by Kjos to enter into Executive Session at 9:30 AM for personnel as per SDCL 1-25-2. Motion carried. Chairman Sinner reconvened the regular session at 10:01 AM.

AMBULANCE: Director Madsen gave an update on the ambulance service with August having 33 calls so far and had discussion on 2010 Ford E 350 (van) body style for transfers with 63,000 miles for \$25,000.00.

NEW HIRE: Moved by McGregor-Okroi, seconded by Walter to approve Liberty Strutz as a part time Ambulance EMT at \$16.00/hr with no benefits, effective August 20, 2024. Motion carried.

ALADTEC: Ambulance Director Madsen asked for approval to purchase ALADTEC (Multi-Use program) to help with reporting and scheduling for an annual fee of \$1,920.00 and a one-time set up fee of \$590.00. Moved by Marx, seconded by Kjos to table the discussion. Motion carried.

Moved by McGregor-Okroi, seconded by Marx to approve the second reading and adopt Ordinance #2024-1. An ordinance amending Day County ordinance #98-10-1, an ordinance establishing zoning regulations for Day

County, SD, and providing for the administration, enforcement, and amendment thereof, in accordance with the provisions of chapters 11-2, 1967 SDCL, and amendments thereof, and for the repeal of all resolutions and ordinances in conflict therewith as specified in the Ordinance to become effective 20 days after publication of second notice of adoption. ORDINANCE #2024-1

AN ORDINANCE AMENDING DAY COUNTY ORDINANCE #98-10-1, AN ORDINANCE ESTABLISHING ZONING REGULATIONS FOR DAY COUNTY, SOUTH DAKOTA, AND PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT, AND AMENDMENT THEREOF, IN ACCORDANCE WITH THE PROVISIONS OF CHAPTERS 11-2, 1967 SDCL, AND AMENDMENTS THEREOF, AND FOR THE REPEAL OF ALL RESOLUTIONS AND ORDINANCES IN CONFLICT THEREWITH

Notice is hereby given that Ordinance number 2024–1 establishing permanent zoning regulations for Day County South Dakota, with such regulations being set forth in the document, entitled Zoning Regulations; providing for restrictions, district boundaries, and providing for repeal of all ordinances or parts thereof in conflict therewith. Day County is adopting this ordinance in order to protect the public health, safety and general welfare of its residents and the public. This ordinance was duly adopted by the County Commission on the 20th day of August, 2024 and will become effective twenty days from the date of its last publication.

First reading: August 6, 2024 Second reading: August 20, 2024.

First publication date: August 26 and August 31, 2024.

Second publication date: September 2, 2024 and September 7, 2024. Effective date: Twenty days after publication of second notice of adoption.
