The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, March 18, 2025, in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Sinner. Members present: Commissioners McGregor-Okroi, Torrence, Aldrich and Kjos. Others: States Attorney Knight, Auditor Kading, Treasurer Zubke, Bryan Anderson, Paul Dulitz, Ben Braaten and Brenner Cariveau-R&F.

PLEDGE: Chairman Sinner led the members in reciting the Pledge of Allegiance.

The Planning & Zoning board voted to have the set back of 1/2 mile (2640 ft.), a petition was then turned in, which then took the setback to a County vote in the November election. The voters voted it down in the election, which in return took the set back of the windtowers to the original 1,000 ft.
