The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, July 22, 2025, in the Commissioners Chambers in the Day County Courthouse. **PUBLIC COMMENT:** On behalf of the Ambulance crew, David Dulitz commented on the good replacement purchase of the ambulance and requested a more detailed list of the Ambulance Director's position.

**BOILER:** Custodian Brian Holland gave Commission an update on the courthouse boiler system. Holland will contact Climate Systems and have them present to the Commission with an updated report on the Courthouse boiler system and estimates on preventative maintenance and future replacement.

**EXECUTIVE SESSION:** Moved by Torrence, seconded by McGregor-Okroi to enter into Executive Session at 9:28 AM for legal as per SDCL 1-25-2. Motion carried. Chairman Sinner reconvened the regular session at 9:45 AM.

**BUTLER BRIDGE:** Superintendent Braaten gave an update to the Commissioners that States Attorney Knight is currently working on discussions with engineers and the railroad to convert back to the original agreement with the railroad being the general contractor of the bridge project.

**SOUTH DAKOTA OPEN MEETING LAWS:** Auditor Kading presented each Commissioner with a guide to South Dakota's open meeting laws. Moved by McGregor-Okroi, seconded by Torrence to approve to accept and review the guide. Motion carried.

**RENEWAL:** Moved by Aldrich, seconded by Kjos to approve the renewal contract with KELO land, hire-click for \$708.00. Motion carried.

**JAIL:** Sheriff Schreur held discussion on 2026 budget. Moved by Torrence, seconded by McGregor-Okroi to approve Sheriff Schreur to increase 2026 repairs & maintenance budget from \$50,000 to \$176,305.01. Motion carried.

**AMBULACE EXECUTIVE SESSION:** Moved by Kjos, seconded by Aldrich to enter into Executive Session at 10:43 AM for personnel as per SDCL 1-25-2. Motion carried. Chairman Sinner reconvened the regular session at 12:14 PM.

**EXCUSED:** Commissioner McGregor-Okroi left at 12:14 PM.

**HIRE:** Moved by Torrence, seconded by Aldrich to approve Melissa Sackreiter as part-time interim Co-Director for the Ambulance for \$25.00/hr, effective 7-12-2025. Motion carried.

**AMBULANCE NEW HIRE:** Moved by Kjos seconded by Torrence to approve hiring Casey Zochert-Huffman as a part time EMT at \$17.00/hr with no benefits effective 7-22-2025. Motion carried.

**BUDGET:** The 2026 Budget was discussed. The Board made changes to the following departments: Jail+\$126,305.01 (repairs \$ maintenance), Ambulance-\$41,500.00 (-\$6,000.00 building rental, -\$500.00 for mileage, -\$5,000.00 training & equipment, and -\$30,000.00 for equipment), Economic Development -\$6,500.00 (budget request reduced).

**2026 BUDGET:** Move by Aldrich, seconded by Kjos to accept the proposed budgets for the 2026 budget year. Motion carried.

**ADJOURNMENT:** Moved by Torrence, seconded by Kjos to adjourn until 9:00 AM, Tuesday, August 5, 2025, to convene in the Commissioners Chambers in the Day County Courthouse. Motion carried.
