## DAY COUNTY COMMISSION WEBSTER, SOUTH DAKOTA October 21, 2025

The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, October 21, 2025, in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Sinner. Members present: Commissioners McGregor-Okroi, Torrence and Kjos. Absent: Commissioner Aldrich. **PLEDGE:** Chairman Sinner led the members in reciting the Pledge of Allegiance.

**CORRESPONDENCE:** Day County Veterans Service Office invites all County veterans and their spouses, county commissioners and elected officials to the 4<sup>th</sup> Annual Day County Veterans Banquet on Saturday, November 8<sup>th</sup>, 2025 at the Webster Armory with the social at 5:00 PM and the Banquet at 6:00 PM.

**PUBLIC COMMENTS:** Paul Dulitz asked if there were any active lawsuits on the county. States Attorney Knight stated that there are no current lawsuits as of now where the county is primary defendant. Glenn Gebur suggested having an ambulance board to help with some of the duties put on commissioners and eliminate some of the executive sessions. Gebur also suggested a better video set up for Commission meetings.

**JAKE BRAKING:** Al Block discussed jake braking on Hwy 12, 6 <sup>3</sup>/<sub>4</sub> miles east of the intersection of Hwy 25. Sheriff Schreur was not aware of a state law that prohibits jake braking, though the county can enact an ordinance for no dynamic engine braking. Commissioners and States Attorney Knight will be looking further into the process before any decisions are made.

**E-911 CONTRACT:** Sheriff Schreur presented commission with the 2026 E-911 contract from E-911 Communication Center in Watertown. Moved by Kjos, seconded by Torrence to approve Chairman Sinner to sign the E-911 service contract 2026. Motion carried.

**ASSIGNED FUNDS:** Moved by Torrence, seconded by McGregor-Okroi to approve electrical repairs of \$4,748.00 from Ridge Electric Inc. and floor repairs of \$14,118.43 from South Dakota Lumber & Design LLC for Capital Outlay for the jail. Motion carried.

**JAIL WALL:** Sheriff Schreur informed the commission that there is a wall with a crack in it that will need fixing soon. Schreur will keep commission updated on that future project.

**PLANNING & ZONING:** Moved by McGregor-Okroi, seconded by Kjos to recess the regular session at 9:24 AM, to convene as Planning, Zoning and Drainage Board. Motion carried. Chairman Sinner reconvened the regular session at 9:59 AM.

**HIGHWAY R.O.W:** Moved by Kjos, seconded by Torrence to approve occupancy on R.O.W. for road boring for Michael Herr, 419<sup>th</sup> Ave in Section NW 29, Township 121, Range 58. Motion carried.

**RAISE:** Moved by McGregor-Okroi, seconded by Kjos to approve Highway department employee, Brian Buxton for a one-year wage increase from \$23.73 to \$24.23 effective 10-19-2025. Motion carried.

**BOILER:** Moved by Torrence, seconded by Kjos to approve boiler specifications and approve to advertise. Motion carried.

**MAINTENANCE:** Brian Holland presented quotes for tile replacement in the Courthouse. Moved by McGregor-Okroi, seconded by Torrence to approve the quote from Tile Tech Inc. for a total of \$12,975.00 to make the repairs. Motion carried.

**EXECUTIVE SESSION:** Moved by Torrence, seconded by McGregor-Okroi to enter Executive Session at 10:16 AM for personnel as per SDCL 1-25-2. Motion carried. Chairman Sinner reconvened the regular session at 11:07 AM.

**AMBULANCE:** Moved by Torrence, seconded by McGregor-Okroi to approve temporary pay scale for out-of-town (minimum of 10 miles) ambulance employees. Those employees will be compensated for their time away from home. Out-of-town ambulance employees will receive their hourly rate from 6AM-6PM, Out-of-town ambulance employees will be at the on-call rate from 6 PM-6 AM unless they go on an ambulance call. Only when the pager goes off and they go on a run, do they receive the hourly rate, effective 11-2-2025. Motion carried.

**INSURANCE:** Leslie Hendrickson with North Point Financial Partners discussed with the board county health insurance premiums, decreasing 18 percent for 2026 and other additional benefits. Moved by Kjos, seconded by McGregor-Okroi to continue with the same policy for health insurance and additional benefits for 2026. Motion carried.

**FLU SHOTS:** Motion by Torrence, seconded by Kjos to allow the Community Health Nurse to give County employees flu shots and to bill their health insurance for the cost. The County will pay any balance after insurance. Motion carried.

**HOLIDAY CLOSURE:** Day County Courthouse and Highway Department will be closed on November 11, 2025 in observance of Veterans Day.

**ADJOURNMENT:** Moved by Kjos, seconded by Torrence to adjourn until 9:00 AM, Thursday, November 4, 2025, to convene in the Commissioners Chambers in the Day County Courthouse. Motion carried.
