The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, December 16, 2025, in the Commissioners Chambers in the Day County Courthouse. 2026 WAGES: Moved by Torrence, seconded by Kjos to approve a wage increase of \$1.00 per hour for all County employees who have been employed for more than six months, excluding ambulance employees. Ambulance employees are as followed: Director Sackreiter at

\$29/hr, Ambulance Paramedics & Registered Nurses at \$30/hr, Advanced EMTs at \$25.00/hr, Basic EMTs at \$20/hr and EVOC Drivers at \$16/hr. Ambulance on-call time during the day is at \$3/hr and holiday, nights and weekends at \$5/hr. Motion carried.

LEPC: Moved by Kjos, seconded by Torrence to move \$1,656.92 from Fund Balance for Emergency Management (226-276.05) to Restricted Fund Balance for LEPC (226-274.01). Motion carried.

INTEREST TRANSFERS: Moved by Torrence, seconded by Kjos to approve the Auditor's office to make interest transfer for year end. Motion carried.

AMEND RESOLUTION #2025-03: Moved by Torrence, seconded by Kjos to amend resolution #2025-03 with amending the general-purpose county levy to 2.288\$/1000.00 and county road and bridge to 0.829\$/1000.00 due to the TIF increment value. Motion carried.

HWY APPOINTMENT: Moved by Kjos, seconded by Torrence to appoint Jordan Schmieg as Highway Superintendent for two years (2026-2027) as per SDCL 31-11-1. Motion carried.

ADJOURNMENT: Moved by Torrence, seconded by Kjos to adjourn until 9:00 AM, Tuesday, December 30, 2025, to convene in the Commissioners Chambers in the Day County Courthouse. Motion carried.
