

DAY COUNTY COMMISSION
WEBSTER, SOUTH DAKOTA
January 6, 2026

The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, January 6, 2026, in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Sinner. Members present: Commissioners Aldrich, Torrence, Kjos, and McGregor-Okroi (via phone). Others: Auditor Lehman, Deputy Auditor Bremmon, States Attorney Knight, Treasurer Zubke, Highway Supt. Schmieg, Sheriff Schreur, Glenn Gebur, Paul Dulitz, Al Block & Connor Handrahan-R&F.

PLEDGE: Chairman Sinner led the members in reciting the Pledge of Allegiance.

OLD BUSINESS: Chairman Sinner called for any old business. No old business.

CLOSE FY2025: There being no further business for 2025, moved by Aldrich, seconded by Torrence to adjourn the 2025 commission. Motion carried.

NOMINATION FOR 2026 CHAIRMAN: Auditor Lehman called for nominations for Chairman of the Day County Board of Commissioners for 2026. Moved by Kjos, seconded by Torrence to nominate Commissioner Sinner as Chairman for 2026 and that nominations cease. Unanimous vote was cast. Motion carried. Commissioner Sinner took his place as Chairman.

Chairman Sinner called for nominations for Vice Chairman of the Day County Board of Commissioners for 2026. Moved by Torrence, seconded by Aldrich to nominate Commissioner Kjos as Vice Chairman and that nominations cease. Unanimous vote was cast. Motion carried. Commissioner Kjos took his place as Vice Chairman.

REVIEW OF OPEN MEETING LAWS: Commissioners were provided with a copy of Conducting the Public's Business in Public and State of South Dakota Boards and Commissions Meeting Guidelines. Moved by Kjos, seconded by Aldrich to note Commissioners reviewed the open meeting laws. Motion carried.

CORRESPONDENCE: Wildlife Damage Management 2025 Annual Report. This will be held in the Auditor's office.

PUBLIC COMMENTS: Paul Dulitz asked Commissioners to state their goals for 2026. Chairman Sinner responded that they are the same as last year. Glenn Gebur mentioned he attended a convention in Watertown where an AI-Center was mentioned and his concern on the drainage it will take on our electricity and water. He would also like to see a quarterly financial statement for Ambulance Services so the taxpayers know the amount of money coming in and going out.

MEAL REIMBURSEMENT

Employees will need to submit meal receipts before receiving reimbursement for day and overnight meetings. Meal expenses will be reimbursed at a flat rate not to exceed \$40.00 per day. No meal expenses will be reimbursed unless a duly executed voucher is prepared and submitted to the Board of County Commissioners. Meal reimbursement for non-overnight travel will be reimbursed and added to gross payroll up to the maximum amounts as listed above. Mileage: Day County will reimburse state rate per mile for personal vehicle.

WEED BOARD PER DIEM:

PLANNING, ZONING, AND DRAINAGE

INDIGENT BURIAL

For those county residents who die in a state of indigence or who otherwise qualify under SDCL 28-17, the Community Service Director shall allow burial and funeral expenses as follows:

A.	Embalming, casket and services (adult)	\$3,000.00
B.	Cremation, including urn and services	\$2,000.00
C.	Cremation without services	\$1,500.00
D.	Invoice cost of the outer container (grave liner/vault) plus delivery cost and set-up, equipment charges	invoice cost
E.	Opening and closing of grave/burial lot	\$550.00
F.	Mileage	\$400.00

G. Other Services paid to other providers when death occurs out of area and other funeral homes must do removal and preparation services \$800.00

All county funerals must be approved in advance by the Welfare Director or County Auditor. The Board appoints Nicole Kwasniewski as Welfare Director.

TREASURER: Moved by Kjos, seconded by Aldrich to approve the Investment Policy for 2026 provided by Treasurer Zubke. Motion carried.

AMBULANCE: Moved by Aldrich, seconded by Kjos to approve new hire Ashley Smaltz start date of 01/06/2026 as a paramedic at \$30.00/hour, eligible for out-of-town pay, with no benefits. Motion carried

STATE'S ATTORNEY: Moved by Torrence, seconded by Kjos to approve Attorney John Knight's salary increase from last meeting's motion of \$83,500 to \$82,400 for 2026 at his request as budgeted. Motion carried.

Moved by Torrence, seconded by Kjos to approve Attorney John Knight to proceed working with the SD Department of Transportation to move the speed limit sign in hopes of controlling the jake braking on Hwy 12, 6 ¾ miles east of the intersection of Hwy 25. Motion carried.

SHERIFF: Moved by Aldrich, seconded by Torrence to approve Sheriff Schreur to purchase a new portable dishwasher. Motion carried.

JAIL COST: Sheriff Schreur also had a discussion on income the Sheriff's Department receives for housing inmates from other counties. Most of the inmates received are unsentenced and the Sheriff's Department is paid \$100.00/day, juveniles are \$250.00/day, sentenced inmates are \$50.00/day for Marshall County and updating contract with Grant and Edmunds County to \$75.00/day. Non-contracted counties pay \$120.00/day for both unsentenced and sentenced inmates.

RECESS: Chairman Sinner called a recess at 9:40am. Chairman Sinner reconvened meeting at 10:00am.

HIGHWAY BID OPENING: Bids received and opened by Highway Supt. Schmieg for Tires for 2026 were Twin Valley Tire, Webster Tire and Pomp's Tire Service (Aberdeen). Moved by Aldrich, seconded by Torrence to accept the bids of Twin Valley Tire (Webster) and Webster Tire based on lowest price and availability. Motion carried. Fuel bids received were from Sioux Valley for \$.15 over cost for gas and diesel and Coles Petroleum for \$.23 over cost for gas and diesel. Moved by Aldrich, seconded by Kjos to accept bid from Sioux Valley Coop. Motion carried. Highway Supt. Schmieg mentioned he is still waiting on quotes for the Truck Snow Wings.

CLOSURE: Day County Courthouse & Highway department will be closed Jan. 19th, 2026, in observation of Martin Luther King Day.

VSO: Moved by Torrence, seconded by Aldrich to approve Chairman Sinner to sign the State Aid Agreement. Motion carried.

FUNDS TRANSFER: Moved by Aldrich, seconded by Torrence to moving capital outlay for unassigned to assigned as budgeted for the boiler project. Motion carried.

MUSEUM MOVING EXPENSE: Moved by Kjos, seconded by Aldrich to approve paying \$5000 of invoice to Dial-A-Move, INC. Motion carried.

ADJOURNMENT: Moved by Kjos, seconded by Aldrich to adjourn the meeting until 9:00 AM, Friday, January 23, 2026, to convene in the Commissioners Chambers in the Day County Courthouse. Motion carried.
