

DAY COUNTY COMMISSION

WEBSTER, SOUTH DAKOTA

January 23, 2026

The Day County Board of Commissioners convened in regular session at 9:00 AM, Friday January 23, 2026, in the Commissioner Chambers in the Day County Courthouse. Meeting called to order by Chairman Sinner. Members present: Commissioners Kjos, McGregor-Okroi, Aldrich, and Torrence. PLEDGE: Chairman Sinner led the members in reciting the Pledge of Allegiance.

PUBLIC COMMENTS: Jim Grimes noted that recent local press coverage has highlighted significant public discussion regarding wind energy infrastructure. Drawing on nearly 20 years of experience hosting wind towers in Oak Gulch Township, Grimes characterized the project as a consistent and valuable revenue stream. He highlighted a recent "re-powering" initiative on his property, which upgraded existing turbines with modern blade technology, an advancement he compared to the transition from an obsolete mobile device to a contemporary smartphone. Furthermore, he commended the cleanliness and efficiency of the construction process. Grimes concluded by urging stakeholders to shift their focus from inter-county tax distribution to the substantial, collective economic benefits these projects provide to both local governments and private landowners.

David Pearson expressed opposition to the proposed wind infrastructure, citing his perspective as a property owner on Pickerel Lake. He stated that residents are concerned that the presence of wind towers could negatively impact property values. Additionally, Pearson highlighted concerns regarding the visual impact of synchronized red lighting, noting that such flickering across the landscape could diminish the area's appeal and potentially disrupt the regional economy by affecting local revenue.

Reed Mahlke, Attorney at Law representing Day County Action Alliance, expressed concern that this proceeding might be the final opportunity for public comment. On behalf of his clients, Mahlke formally requested a setback requirement of three-quarters of a mile, or 3,960 feet. He also recommended that the County implement its own independent bonding requirements in addition to the standards mandated by the Public Utilities Commission. Finally, Mahlke noted that while his clients remain fundamentally opposed to the installation of wind towers, they urge the County to exercise its maximum regulatory authority over the project.

WATERTOWN 911 COMMUNICATIONS DIRECTOR: Troy VanDusen held a discussion with the Commissioners on what the Watertown 911 Communications Center has provided for our County since 2009, and that he would like to keep that partnership. He shared that they have a 96.6% rate of calls received which are answered within 10 seconds, he also explained that the State increased the 911 surcharge fee from \$1.25 to \$2.00 per phone line effective July 1st of 2024 which is what pays for the 911 service.
