

**DAY COUNTY COMMISSION  
WEBSTER, SOUTH DAKOTA  
February 3, 2026**

The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, February 3, 2026, in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Sinner. Members present: Commissioners Kjos, McGregor-Okroi, Aldrich, and Torrence. Others: Auditor Lehman, States Attorney Knight, Treasurer Zubke, Nurse Aadland, Highway Supt. Schmieg, Rook Dallman, Paul Dulitz and Connor Handrahan -R&F.

**PLEDGE:** Chairman Sinner led the members in reciting the Pledge of Allegiance.

**CORRESPONDENCE:** None.

**PUBLIC COMMENTS:** Paul Dulitz expressed support for the proposed wind tower set back of four times the structure's height. However, he recommended adjusting the setback requirements: a two-mile setback for municipalities with populations exceeding 500, while maintaining the one-mile proposal for those under 500.

**BRIDGE REINSPECTION  
PROGRAM RESOLUTION #2026-03  
FOR USE WITH SDDOT RETAINER CONTRACTS**

WHEREAS, 23 CFR 650 Subpart C, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

THEREFORE, Day County is desirous of participating in the Bridge Inspection Program. The County requests SDDOT to hire IMEG for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.
