The Day County Board of Commissioners convened in regular session at 9:00 AM, Tuesday, June 30, 2026 in the Commissioners Chambers in the Day County Courthouse. Meeting called to order by Chairman Sinner. Members present: Commissioners Kjos, McGregor-Okroi, Aldrich & Torrence, Others: State's Attorney Knight, Auditor Lehman, Treasurer Zubke, Dean Townsend, Harry Knapp, Paul Dulitz, Kelly Brandlee and Timothy Gibson R&F.

PLEDGE: Chairman Sinner led the members in reciting the Pledge of Allegiance.

CORRESPONDENCE: None.

PUBLIC COMMENT: Harry Knapp shared concern that he felt there would be an overflow of people at the U.S. Army Corp. of Engineers meeting in the community room in the courthouse basement and asked the board to consider live streaming in other rooms.
